NEW FEATURES

Per Diem

A Per Diem utility is available from Service Entry by hovering near the plus sign add button.

- Services may be created for clients who have Enrollment records.
- Services may be created for each day up to a month.
- Service Components must be entered and must map to a unique Service Code Combination.
- Service Programs must match Enrollment programs.

If an error occurs that would prevent a Service from being saved, that error must be corrected before services are created. For example, affected clients must have a valid Client Diagnosis for the Service Dates. A message indicates how many services are created, or if there are errors.

Documents on Timeline

A client's documents are now displayed on the Timeline.

The Documents depiction is not configured as a standard VHR Category Depiction because of the way in which Documents are stored in Alfresco, outside of the EchoVantage database.

Categories may now be assigned to Documents for filtering purposes.

Client Tab Security

- New Options have been added Clients within Configuration>User Groups>Menu Options
- Each Clients tab may be enabled or disabled by User Group.
- The defaults is set so that all are enabled.

Diagnosis Description Searching

- Diagnoses may be searched by Description in Client Diagnosis, Service Entry, and DSM Mapping.
- As with Codes, at least 3 characters must be entered before search results are available.

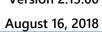
Service Entry Program Defaults

- If a client has Enrollment record(s), the Program Code from one of the active Enrollments will default during Service Entry.
- The default Program may be edited.
- If a client does not have an Enrollment, no default will be entered and any Program code may be selected.

Revenue Codes

- Revenue Codes for institutional services may now be entered in Configuration>Service Definitions>Rates or Configuration>Payers>Rates.
- If a Revenue Code is entered, a check box allows a user to indicate that Billing Codes should be excluded when a Revenue Code is reported.

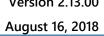
Future releases will include the ability to create 837I and UB04 bills that will use these values.
