NEW FEATURES

GL Posting

- Charges, Payments, and Adjustments can now be added to GL Posting jobs.
- Any Transactions not matching mapped combinations in Configuration>GL Mapping will product errors and will not be marked as posted or included in the GL Posting CSV file.
- When creating a job, a Transaction Cut-Off Date is required. This date must be on or before the Period Month/Year. Transactions with dates on or before the Cut-Off Date will be included if not already posted.
- A Fiscal Period Month/Year must be entered.
- Anything included in a Finalized posting will have a PostToGL = "Y", and the GLDebitAccount and GLCreditAccount will included the account to which the transaction was posted.
- The Cut-Off Date, Fiscal Period, and Transaction Date can be found in the JobProperties table for that Job.

Progress Note Indicators

- On the Services screen, an indicator displays the status of Progress Notes and Signatures.
 - A blue page displays if a note is not entered, but the Service Definition>Progress Notes checkbox does NOT indicate that a note is required.
 - An orange page displays if a note is not entered, while the Service Definition>Progress Notes checkbox DOES indicate that a note is required.
 - o A blue pencil displays if a note has been entered and has at least one signature.
 - An orange pencil displays if a note has been entered but not signed.
- On a Service, the Progress Note button color and text alert the user to the state of the Progress Note.

Unlocking Progress Notes

- A new check box has been added to Staff>Profile to indicate if an individual staff person should be able to unlock a note.
- Staff with the check box selected are presented with an "Unlock Note" button once a progress note has been signed and locked.
- Only Progress Notes associated with Services having a "Not Ready" Status can be unlocked.
- Once unlocked, all Signatures are removed.
- The Signed Records and Signatures tables are audited, and auditing cannot be removed.
