NEW FEATURES

Wait List Notes

Continuous notes can be now by added to Wait list entries. After clicking the  NOTES button, previous notes may be viewed, or a new note added by clicking the plus sign.

Once Notes have been added to a Wait List entry, the  NOTES icon is shaded to indicate that Notes are present.

Claims Updates

- A **SELECT ALL** button was added to the bottom of the Claims screen. Users can now Select All Claims at once when a Reprocessing action is required.
- When performing Reprocessing tasks, the list of Claims in Claims Management is now persistent until the user changes filters.

Self Pay Statement Responsibility

- The Self Pay Statement now reflects the Responsibility percentage assigned to a Guarantor.
- The percentage reduces the amount owed by the Guarantor on the Statement balance.
- System transactions are not affected; the percentage is displayed only on the Statement.

Vital Signs Form

- A new Vital Signs form has been added and may be configured for use on the Timeline.
- This Vital Signs form meets the requirements of Meaningful Use Stage 3 Certification.

Important: if your database already has a dbo.VitalSigns table, that table will need to be renamed or dropped in order to run the updates for this release.

835 Patient Responsibility

- When importing an 835, users may now choose whether or not Patient Responsibility amounts should be imported into the Payment entries.
- If Patient Responsibility amounts are not imported with payments, they do display informationally under Messages.

Medication Signatures and Pending Changes

- If the Medications form is set to Signable, the form may be signed when an End Date has been entered in DrFirt and sent to the Timeline.
- If further changes are made to an End-Dated Medication, Staff who have permissions may unlock the records to remove signatures and receive the changes.
- Staff may be granted permissions to remove Medication signatures in Staff>Profile.
- Two new Alerts have been added to assist in the Medication signature workflow:
 - "Signed Medication Has Pending Update"
 - "Unsigned Medication with an End Date"
- Alerts are configured in Configuration>Setup>Alerts.

4933	The search for Clients was enhanced in an attempt to make it more precise.
