Future enhancements are planned for an upcoming release. These include:

- The ability to automatically add or update Client Payers when a client is eligible but does not have an active Client Payer record.

# **SNOMED** Diagnosis

SNOMED Diagnoses are used in CCD exchanges as well as other regulatory reporting.

- If your organization uses SNOMED diagnoses, enable SNOMED Diagnoses in Configuration>Setup>Diagnosis.
- Once this check box is selected, the SNOMED box displays below the ICD-10 box in Client Diagnosis.
- No mapping currently exists between SNOMED and ICD-10 codes so care must be used is selecting a correct SNOMED code.

# Services Screen Changes

The Services screen is now paginated to allow agencies with large volumes of data to better manage records.

In a future release, a Bulk Action to mark all services as Ready will be added. Until then:

- Up to 500 Services will display on the first page.
- Users may mark the first 500 records as ready, and then will need to go to subsequent pages to mark the next 500 until all Services are Ready.
- Individual Services can be Marked as Ready or Deleted with the available buttons.
