## NEW FEATURES

### Maximum Number of Services in a Bundle

An option to specify the Maximum Total Services (number) is an available option on the bundled service definition screen.

- This is a required field that defaults to 999.
- A user defined value can be entered and must be greater than the minimum number.
- When the maximum is met in processing, any remaining services stay available and can be picked up in a subsequent bundle.

### Reporting on Number of Services in a Bundle

A new option of "Number of Services in Bundle" is available in the Unit Calculation drop-down listing when a Service Definition is a Bundled Service. When this option is selected in *Configuration>Rates and Payers>Service Definitions>Rates*, no other Unit Calculation inputs are needed. In processing, the bundled number of units used to calculate the charge will be equal to the number of detail services in the bundle.

### Place of Service Overrides

Billing users can now specify an override for a Place of Service on a per Payer basis that will be used during 837 creation. The current method of storing Place of Service in the *Organizations* Configuration menu option that requires Defined Filters remains.

- Payer specific mappings are defined in *Configuration>Services/Payers* in the new *POS MAPPINGS* tab by selecting a Place of Service (Location Component) and a Payer Place of Service.

### During 837 Creation

- When a Service matches on a Payer and the location component of that Service has a Service override defined, the override location will be used in the SV1 section.
- When a service matches on a Payer, and the location component of that Service does not have a Service override defined, then the Place of Service from the Organization that has a matching Defined Filter will be used in the CLM section.

### Read-Only Option for Most Client Tabs

Administrators now have the option to specify Read-Only or Edit access for most of the Clients tabs when selecting the available Menu Options for a User Group in *Configuration>Staff/Users>User Groups>Menu Options*.

### Modifiers for Direct Fee Services

Modifiers for Direct Fee Services can now be entered on the Service Definitions *Rates* tab. The Billing Code and Modifiers section are included when the *Billable to most payers* option is selected from the drop-down listing.



### SubPrograms Linked to Programs

A new *Programs* menu option found in *Configuration>Services/Payers* allows users to enter SubProgram information for use on the Enrollments tab. The Program page allows users to select a Program Service Component from a list and assign SubProgram values to it with a Name, Descriptions, and Start and End Dates.

When a Program is selected in Enrollments, only the SubPrograms associated with that Program are available for selection in the drop-down listing.
