SC-94	SQL error running the Cost Report Extract – The allowed length of VARCHAR field for Medicare and Medicaid plan and group IDs increased to 100 to accommodate the length.
SC-100	ADP Medi-Cal Claim 30 day to 6 Months Late – ADP has been updated to increase the timely submission period from 30 days to 6 months past end of service month.
SC-110	Crystal Pool Users are Not Being Released After a User Views a Report – Additional code added to ensure license release.
SC-111	Utilization Control screen ignores user group permission levels – Permissions corrected to respect group level permissions.
SC-113	Utilization Control Renew isn't renewing – Corrected so that when a new renew date is entered the screen clears and refreshes.

SC-114	Utilization Control Delete button occasionally missing - This bug was corrected to always show the delete button.
SC-115	Utilization Control screen refresh – Corrected screen refresh so that when a new consumer is selected, the information for the new consumer is displayed as well.
SC-131	Add Payor Address to 837 – Option to include the Payor address has been added to the 837.
SC-132	sc_calculate_current_FATP fails on bad data – When family ATPs overlap sc_calculate_current_FATP fails because it can't determine which FATP record to use. This has been changed to use the family ATP with the most recent begin date.
SC-133	s/b usp_UMDAP_Create_Writeoff should not apply to ADP – Corrected issue so that s/b usp_UMDAP_Create_Wrtieoff will not apply to ADP.
SC-140	Browser error updating UC record – Corrected the error where unselecting the Lead Fac/Prog box and clicking update caused a 'File not found' error.
SC-154	Script errors adding an EV transaction – A null value would cause script errors when adding a consumer to create EV transactions. The related SQL code was changed to prevent JavaScript from using null.
